SUBJECT: **Interested in Helping Your Community - Consider Serving on the Templeton CSD Board of Directors**

The Templeton Community Services District is an independent government agency that provides Water, Sewer, Fire and Emergency Services, Solid Waste, Parks and Recreation as well as limited drainage and street lighting services for about 8,000 residents. Board Members serve an important role in how these services are provided by establishing policies, defining priorities, setting utility rates, and ensuring tax dollars are spent efficiently and effectively.

The Board of Directors is made up of five persons, serving staggered four-year terms, and meet twice a month on the first and third Tuesday at 7 pm. Board Members also serve on Committees and may represent the District on other regional agencies or commissions. Board Members earn \$150 per day while attending meetings or training, up to a maximum of \$600 per month.

Effective Board Members do not need to have expertise or even experience with the services the District provides, but do need to be able to put in the time necessary to come up to speed with the issues the District is facing, spend a few hours before each meeting reviewing materials and preparing for the meeting, and be able to work with the other members of the Board, District staff and the Community to provide for the best outcomes for the District and its residents and businesses.

Why are there openings on the Board?

Due to recent resignations of Board Members Jardini and Pearson, the District has two available seats on the Board of Directors for the time remaining on those two terms. The first term is through December 3, 2024, with the second term through December 1, 2026.

The District is looking for two interested persons to be appointed to these terms and fulfill these important roles. The only requirements for these positions are that the individual be a registered voter and reside within the District's boundaries.

The shorter of the two terms is up for election in the November 5, 2024 General Election. There is also the opportunity to run for election to a four-year term, which would commence on December 3, 2024. The nomination period to file declaration of candidacy forms for the November 5, 2024 Election is from July 15, 2024 through August 19, 2024. Interested candidates need to call (805) 781-5228 to make an appointment with the County of San Luis Elections Office to take out nomination papers.

The Templeton Community Services District is asking that residents who may be willing to serve on the Board of Directors complete the application at the following link <https://templetoncsd.org/DocumentCenter/View/2083/Public-Service-Application>, by July 9, 2024. Additionally, it asks that any resident contemplating serving on the Board attend the July 16th Board Meeting at 7:00 p.m. in the District Board Room located at 206 5th Street, Templeton (remote participation is also available at <https://us02web.zoom.us/j/81096261127?pwd=anltY2xWUGRhSXlOUzVoWlFwZGFaUT09> or by calling 1-669-900-6833 with Meeting ID 810 9626 1127 and Passcode 003276) where the Board of Directors may consider making an appointment to these vacant seats.
