

# KPRL CONTEST RULES

REVISED APRIL 2017

The following are basic contest rules applying to any and all contests run on KPRL 1230AM Radio. Each contest may have its own special qualifications and eligibility rules, in which case a separate list of rules will be available for public inspection.

1. All KPRL contests are open to all listeners, unless a specific age is required and specified by an advertiser, agency or by KPRL.
2. Listeners may win, or qualify, only once every sixty days. If a listener wins more than once per thirty days the listener may collect only the first prize won. Winners of major prizes (contest valued at \$600.00 or more) may not win any contests sponsored in whole or part by KPRL for a period of 6 months from the winning day.
3. All winners will be responsible for any and all taxes on all prizes won.
4. All prizes, unless otherwise specified by KPRL, must be picked up within 30 days from the date won, during regular business hours; 8 AM-4:00 PM Monday through Friday at the KPRL studios and offices located at 32nd & Oak Street, Paso Robles, CA. KPRL will not notify winners of time remaining on prizes to be picked up. It is the responsibility of the winner to claim their prize within the specified time limit.
5. All prizes not claimed within a 30 day period will become property of KPRL. KPRL may, at its discretion, award the prize to another listener, either in the same contest, or at a later date and separate contest. Every attempt will be made to award all major contest prizes, whether claimed by the original winner or not.
6. In case of a dispute over telephone line malfunctions, human error, circumstances beyond the control of KPRL and/or other mishap, the decision of KPRL management is final.
7. In the event that 2 phone lines are "tied together" during a phone-in contest, the entire phone call will be disqualified and another call will be taken. KPRL cannot award duplicate prizes to both parties in a "tied together" situation, which is a circumstance beyond the control of the station.
8. Winner may not substitute a prize or place a monetary value on the item(s) won. No transfer or substitution of prizes is permitted.
9. KPRL may, due to the unavailability of prizes awarded, substitute another prize for the original, provided the substitute prize is of the approximate dollar value of the original prize awarded.
10. KPRL Radio, employees of, their advertising agencies or representatives, vendors, attorneys and assigns are not responsible in any way for any defects, malfunctions, or any unforeseen problems with prizes, these must be taken up with the manufacturing company. KPRL radio cannot be held liable for any loss incurred in travel. Winner, in accepting the prize, agrees that all risks inherent in travel and their safety and welfare are their sole responsibility and hold KPRL radio strictly harmless, limitations of airlines apply.
11. Employees of KPRL and their relatives, their advertising agencies or representatives, vendors, attorneys, assigns, and employees or other radio stations and their immediate families and participating sponsors are not eligible to participate or win any and all KPRL contests.
12. Unless otherwise specified, no prizes will be mailed. All must be claimed in person by the winner. Designated winner's representatives will be allowed to claim prizes only if KPRL has been notified in writing and by telephone that such a representative will be picking up their prize and that they have been given the power of attorney to sign a prize for the winner. Winner must claim prize within 30 days from the day that the winner won the prize. Winner must use prize within the allotted time and date stated on contest rules. Dates can not be extended or changed.

13. Additions and deletions of these rules may be made at any time by KPRL management, without notice, but will be put in writing and be available for public inspection.
14. KPRL, their agencies, sponsors, employees and representatives absolve themselves and shall be held harmless from any action or liability arising from any KPRL contest or the prizes awarded in a contest.
15. All KPRL entries become property of KPRL.
16. Multiple entries by the same person(s) of a family will be disregarded and may be deemed by station management as cause for disqualification unless otherwise stated.
17. Any contest conducted at a facility where a paid admission is required, may be entered at KPRL studios prior to the event, or through a station representative at the event, without any paid consideration to enter the event. KPRL must be notified by telephone or in writing at least 24 hours prior to such a contest/event to facilitate staffing for such purposes.
18. Contests conducted at facilities with an age requirement of 21 years and over shall exclude participants who cannot prove they meet this requirement.
19. All contest rules, execution thereof, participation in, winning results, dispute of and any information pertaining to contests are judged by KPRL management staff and are subject to their decision. Decision of KPRL judges is final.

## KPRL REMOTE CONTEST RULES

During remote broadcasts, KPRL may award prizes without prior announcement. Each Announcer, at each remote, will determine the qualifications needed to enter the contest and/or claim a prize.

1. All KPRL remote broadcast contests are open to all listeners. A specific age may be required for some prizes. Announcers shall determine qualifying age and inform listeners accordingly.
2. Only one winner per family during a 30 day period will be allowed to claim a remote broadcast prize. Listeners will be asked as to their eligibility for prizes. Intentional false information may lead to permanent contest disqualification.
3. All other KPRL basic contest rules shall apply to remote contests and prizes, unless otherwise stated.

All contest rules are available for public inspection at the studios and offices.
