Diablo Canyon Decommissioning Engagement Panel in Cooperation with PG&E Will Host a Public Meeting to Discuss Repurposing Opportunities of the Power Plant Site

**Avila Beach, Calif.** – The Diablo Canyon Decommissioning Engagement Panel (Panel), in cooperation with Pacific Gas and Electric Company (PG&E), will host an in-person and virtual meeting **Wednesday, May 22, from 6:00pm-9:00pm** (PT). The meeting is being held to discuss repurposing opportunities of Parcel P, the 750-acre site on which Diablo Canyon Power Plant (DCPP) and its ancillary facilities are located.

Agenda topics will include an update from PG&E on repurposing of Parcel P, a presentation from the County on repurposing options identified in the Environmental Impact Report, a briefing from the Governor's Office on repurposing analysis and funding status, and understanding wind and other clean energy project opportunities for Parcel P.

"PG&E remains on track for extended operations of Diablo Canyon through 2030, as directed by the state. All operating nuclear power plants in the U.S. have a plan for eventual decommissioning efforts of their facilities and we appreciate the Panel's ongoing dialogue regarding Diablo Canyon repurposing when we eventually do transition to decommissioning," Maureen Zawalick, DCPP vice president, said.

"The lands surrounding Diablo Canyon and beneath the power plant are the sovereign and sacred lands of yak tityu tityu yak tiłhini Northern Chumash Tribe (ytt Tribe). It is important that the stewardship voice of ytt Tribe is included in these ongoing conversations about repurposing. ytt Tribe appreciates PG&E's stewardship of our land and their dedication to a carbon-free energy future," ytt Tribe Panel Ex-officio Scott Lathrop said.
