News Director meets the first Thursday of every month with the public from 9:45 AM to 11:00 AM at a local restaurant. This community meeting invitation is radio promoted a week prior to the meeting. Topics of conversation are of local issues, radio broadcasting and employment opportunities

The station also promoted and participated in the September 2017 Pioneer Day committee's auction dinner as host. The Pioneer Day committee raises funds to preserve the local historical museum. KPRL participated in the Templeton 4th of July Celebration Parade, with the Owner/Manager and News Director providing broadcast information and employment opportunities before and after the parade.

The KPRL Owner/Manager and staff participated in the fundraiser/sponsorship for the Youth Softball Camp, answering questions from participants and guests.

KPRL sponsored Boy Scout Troop 60 fundraiser on May 7, 2018, Cattlemen's Western Art Show on April 6-8, 2018, Quota International of Atascadero March 22, 2018 and Parkfield Bluegrass Festival May, 2018.

Participated in other activities designed by the station employment unit reasonably calculated to further the goal of disseminating information as to employment opportunities in broadcasting to job candidates who might otherwise be unaware of such opportunities.

In the past year, the Owner/Manager has given several tours of the radio station to the following, Boys and Girls Club on August 1st & 8th, 2017, local Boy Scout Troop on August 14, 2017 and PRJUSD PRYDE Program tour for kindergarten children on April 5, 2018, Cub Scout tour on July 17, 2018. During the tours, the owner explains the history of broadcasting, how the EAS System works, the role radio plays in the local community, and career/employment opportunities in broadcasting.
