SUBJECT: **Templeton CSD Needs Measure "A" Oversight Committee Members**

The District is seeking a minimum of two interested community members to serve on the Measure A Oversight Committee. **Two additional members are needed on the Committee**, which requires a minimum of three members and currently has only one.

Measure A was passed by District voters in 2019 to impose a special annual tax to fund Templeton Fire and Emergency Services 24/7 staffing. The purpose of the Committee is to independently review and inform the public and the Board of Directors concerning the expenditure of parcel tax revenues and to ensure that such revenues are expended in accordance with the intention of the voters.

The Committee meets twice per year, on an as needed basis, and typically during regular business hours. Committee members must reside within the Templeton CSD boundaries and will serve an initial two-year term.

Committee Members will be required to comply with the District's Conflict of Interest Code and file a Statement of Economic Interest Form 700 under the Fair Political Practice Commission. Interested members of the public should submit an application for consideration by September 7, 2026. Measure "A" Oversight Committee members are anticipated to be selected at the September 15, 2026 Board Meeting.
