Templeton CSD Board of Directors

The Templeton Community Services District is an independent government agency that provides Water, Sewer, Fire and Emergency Services, Solid Waste, Parks and Recreation as well as limited drainage and street lighting services for about 8,500 residents. Board Members serve an important role in how these services are provided by establishing policies, defining priorities, setting utility rates, and ensuring tax dollars are spent efficiently and effectively.

The Board of Directors is made up of five persons, serving staggered four-year terms, and meet twice a month on the first and third Tuesday at 7 pm. Board Members also serve on Committees and may represent the District on other regional agencies or commissions. Board Members earn \$150 per day while attending meetings or training, up to a maximum of \$600 per month.

Effective Board Members do not need to have expertise or even experience with the services the District provides, but do need to be able to put in the time necessary to come up to speed with the issues the District is facing, spend a few hours before each meeting reviewing materials and preparing for the meeting, and be able to work with the other members of the Board, District staff and the Community to provide for the best outcomes for the District and its residents and businesses.

Why is there a vacancy on the Board?

During the nomination period for the November 2024 election, only two candidates, incumbent's Navid Fardanesh and Debra Logan, submitted papers to run for two of three open seats on the Board. Since there are only two candidates, there will not be an election in November for the Templeton CSD Board of Directors. Navid Fardanesh and Debra Logan will hold two of the three seats, and the California Election Code permits the County of San Luis Obispo Board of

Supervisors to appoint someone to the third seat if there are fewer candidates running than seats open.

The Templeton Community Services District is hoping to find some interested residents so the County Board of Supervisors can appoint someone who is willing to fulfill this important role. The term is for four years, beginning in December 2024. The only requirements for this position are that the individual be a registered voter and reside within the District's boundaries.
